C. E. ROSE K-8 SCHOOL

STUDENT UNIFORM AND DRESS CODE

GIRLS' UNIFORM

TOPS: WHITE OR NAVY BLUE

- Shirts with a collar and sleeves; it may be a polo shirt or dress shirt. No emblems, insignias, logos, designs or any writing on the shirts. The approved C.E. Rose School Shirt is acceptable.
- Sweaters may be any color. No emblems, insignias, logos, designs or any writing on the sweaters.
- Approved C. E. Rose School Spirit shirts are acceptable.

BOTTOMS: NAVY BLUE OR KHAKI

- Long Docker style pants, cuffed or not cuffed. Pants are to be worn at the waist (no larger than 2 inches bigger than waist size)
- Walking shorts, cuffed or not cuffed, length longer than fingertips at side to above the knee. The same guidelines apply as are listed above for pants.
- Skirts, skorts/culottes, Capri pants, and jumpers are acceptable.
- In the winter, cotton sweat pants and corduroy pants are acceptable.

BELTS: Black or Brown

- Belts must have permanently attached belt buckle and are to be worn if garment has belt loops; they may not hang down.
- Belts may not be more than one size larger than the waist.

SHOES:

Tennis shoes or any leather-type covered shoes are acceptable. White or black shoelaces only. Socks may be white or navy.

BOYS' UNIFORM

TOPS: WHITE OR NAVY BLUE

- Shirts with a collar and sleeves; it may be a polo shirt or dress shirt. No emblems, insignias, logos, designs or any writing on the shirts. The approved C.E. Rose School Shirt is acceptable.
- Sweaters may be any color. No emblems, insignias, logos, designs or any writing on the sweaters.
- Approved C. E. Rose School Spirit shirts are acceptable.

BOTTOMS: NAVY BLUE OR KHAKI

- Docker style pants, cuffed or not cuffed. Pants are to be worn at the waist (no larger than 2 inches bigger than waist size)
- Walking shorts, cuffed or not cuffed, length longer than fingertips at side to above the knee. The same guidelines apply as are listed above for pants.
- In the winter, cotton sweat pants and corduroy pants are acceptable.

BELTS: Black or Brown

- Belts must have permanently attached belt buckle and are to be worn if garment has belt loops; they may not hang down.
- Belts may not be more than one size larger than the waist.

SHOES:

Tennis shoes or any leather-type covered shoes are acceptable. White or black shoelaces only. Socks may be white or navy.

Uniforms can be purchased in the following stores: Sears, J.C. Penney, Target, Walmart, Factory 2U, Savers.

C. E. ROSE OVERALL UNIFORM RULES:

- Shirts must be worn tucked-in at all times.
- Sleeveless shirts are not allowed.
- No undergarments may show. Girls may wear black or navy shorts under their skirts provided they do not show.
- Blue Jeans or denim pants are not acceptable.
- Baggy or over-sized pants, shorts or shirts are not acceptable and thus prohibited.
- Web belts, chain belts or belts with chains, and Dickie belts are not acceptable.
- For safety reasons, students are to wear covered shoes. Flip-flops, shoes with heels
 greater than 1 inch, or skate shoes are not allowed.
- Full-length tights and knee-high socks/tights are acceptable for girls.
- No hats, caps, or bandannas of any type may be worn on campus except for special designated hat days.
- Excessive jewelry is not allowed.
- Any accessories, which make reference to drugs, alcohol, sex, or gang identification, are not allowed.
- Dark glasses may not be worn inside the building unless a documented health problem exists.

SPECIAL OPTIONAL NON-UNIFORM DAYS

Throughout the school year, there will be special dress days, Spirit days (school t-shirt or school polo shirt), or non-uniform days. These days will be announced as they occur and may include:

- Picture day
- Spirit days
- Field day
- Various incentive days (100% Attendance, etc.)

DRESS CODE PROCEDURES/POLICY

- 1. The C.E. Rose Pre-K-8 uniform dress code was phased-in over a two-week introductory period, which began on the first day of school, August 15, 2005.
- 2. Parent contact will be made for students who fail to comply with the Uniform Dress Policy and student may be asked to do any of the following depending upon the specific circumstances:
 - Turn inappropriate clothing inside out.
 - Change into clothing that may be provided by the school or clothing bank.
 - Change into other clothing which has been brought to school.
 - Remove the jewelry or other accessory.
- 3. The Principal shall have the right, at any time, to exempt a student from wearing the required uniform at school because of extenuating circumstances, if requested in writing by the student's parent or guardian. Extenuating circumstances are limited to religious beliefs or medical/disability conditions that are substantially affected by the uniform requirement.
- 4. The Principal and school staff will offer assistance to families of limited means that cannot afford school uniforms. Such assistance may include referral to the TUSD Clothing Bank, or thrift and second-hand clothing stores. Parents are encouraged to donate used or outgrown uniforms to the Rose Health Office.
